Subject: - Minutes of the meeting/ action plan submitted for necessary advice and approval. Members of Anti-Ragging Committee (ARC) held a meeting on 30th of November, 2021 at 11:30 am in the office chamber of HOD, Zoology with the objective to discuss and finalize the modus operandi to deal with the menace of ragging in terms of the directives of Hon'ble Supreme Court and guidelines by the UGC. After threadbare discussion committee understood the anatomy of the assigned job and accordingly decided/ purposed as under:

- 1. Location of the office of the committee shall be the "Room of HOD Zoology", if some other suitable room/ site is not designated.
- 2. The college campus has sufficient number of CCTV cameras installed and linked with LED panel (138 inches) fixed on the wall in the office chamber of worthy Principal is displaying 36 segments. It is proposed to install CCTV cameras in the boys and Girls hostels to tackle with the menace of ragging.
- 3. In the light of the directives by Hon'ble Supreme Court all the employees of the college be regularly sensitized towards the evils and consequences of ragging and their duties to curb this menace. In this regard worthy principal may obtain an undertaking from its entire staff members that he/she would immediately report if any case of ragging comes to his/her notice.
- 4. It is recommended to constitute Anti-Ragging Squad (ARS) or Task Force of the staff members (Teaching, Non-teaching and Local Fund) to ensure vigil during working hours in the college and odd hours at the hostels.
- 5. To fully sensitize and aware the students following activities are proposed to be performed.
 - I. Publication of a brief brochure entitled "No Tolerance to Ragging" to be handed over to students and staff.
 - Fabrication of different size {3X4 feet(05 nos) and 6X8 feet(02 nos), banners, II. display boards and hoardings with printed material:
 - a) Warm Welcome Freshers, Helpline numbers (Mobile numbers of all the Anti-ragging committee members) and E-mail ID.
 - b) Warning Ragging is prohibited, Ragging is a Crime, Ragging is a punishable offence, stop ragging, don't indulge in ragging, don't be a

- Asking the junior to do an act or perform something which has the effect of causing or generating a sense of shame or embatrassment so as to adversely affect the physique or psyche of a fresher.
- Any act results in Criminal intimidation/ wrongful restrain. Undermining human dignity, Financial exploitation/ extortion and use of force

Consequences of indulging or participating in/ or abetment of ragging can be:

- Suspension from attending classes.
- · Withdrawing/ withholding all benefits like scholarship/ fellowship.
- Expulsion from the hostels/institution.
- Debarring from examinations or participation in any regional, national or international meets, tournaments, youth festival etc.
- · Withholding results.
- Fine as admissible under norms.
- Rustication from the institution for period varying from 01to 04semesters.
- Cancellation of admission.
- Denied/ debarred from admission to any institution.
- For an action parents of the accused shall be approached/ involved as party along with.
- Lodging of FIR with local police under norms.
