1. Marks certificate in original of the qualifying examinations (12th) along with three attested copies.
2. (a) Provisional/Character certificates in original from the Head of the Institution last attended in case of regular students.
(b) Provisional / Character certificates in original from J&K State Board of School Education and character certificate from DSP/SHO (Police) of that area in the case of private candidates.
3. Date of birth Certificate (Secondary School certificate issued by JKBOSE/CBSE) two copies.
4. Four copies of the recent passport size photographs.
5. Category certificate if any (Self attested photocopy).
6. However, the students who have passed their qualifying examination from the Institution other than the J&K State Board of School Education shall have to submit the following Documents in addition to the above.
 - Migration certificate in original from the University/Board from which the student has passed the qualifying examination.
 - Eligibility certificate from the University of Jammu.
7. Declaration (Annexure- I) by all the students seeking admission.
8. Declaration (Annexure- II) by all the students seeking admission.
9. Declaration (Annexure-III) for students who have passed (10+2) examination from Board other than J&K Board.
